Stage-1 Fee deposit

Stage-2 Registration Form

Stage-3 No Dues

The student will submit No Dues after the start of offline classes in the institute.

Stage-4 Registration

Submit your completed Registration Forms along with

- (i) Passport size colored photograph pasted at earmarked location on each form
- (ii) Copy of fee voucher/college fee receipt.
- (iii) College Receipt of late fee, if applicable.
- (iv) Anti-Ragging affidavit both by student and parents.

(v) Affidavit from the students avail PMSS regarding payment of fee after receiving the scholarship from the govt.

'Academic Copy' of Registration form will be retained by the department office after ensuring the correctness of entries.

'Hostel Copy' and 'Student Copy' will be handed over to the student by the department after putting required signatures at earmarked places.

The student will submit 'Hostel Copy' in the hostel and will retain 'Student Copy' as a proof of registration.

NOTE:

1. Date of completing Stage-4 of registration process will be considered as the date of registration. Late fee to be deposited by a student will be determined on the basis of date of registration.
2. Hostel fee will be deposited in the institute as mentioned in stage 1
